Kim Kamin

Though not yet 40, Kim Kamin is already earning a reputation as one of the city's premiere estate planning lawyers.

A partner with Chicago's Schiff Hardin LLP, a law firm known for the quality of its estate planning department, Kamin has quickly built a thriving practice, representing high and ultra-high net worth clients with estate, trust, charitable and related legal needs.

It is a practice destined to grow. Kamin fans say that her hard work, astute planning and outstanding results have led to a growing referral network for the young attorney.

In 2006, she helped the Chicago Bears set up its own stand-alone public charity, Bears Care. In 2007, she helped the Kup's Purple Heart Foundation relaunch a cruise for local veterans. This year she is working with Lawyers for the Creative Arts to establish an estate planning clinic for qualifying artists and entertainers.

Goldberg, a professor of law with Northwestern University, said he has worked with few attorneys with the same drive and commitment.
